Extravaganza Saturday 11 June 2016

Nevill Juvenile Bonfire Society will celebrate the Queen's 90th birthday on Saturday 11th June 2016 with another Extravaganza on Nevill Green. As in past years the event will be held in two parts:-

Fayre between 12.00 noon to 4.30 pm, with displays, games, stalls, and refreshments. Priority will be given to local groups and clubs who wish to support the event by having a stall to raise funds for their own good causes. A form and further details will shortly appear on the Bonfire Society website at *www.njbs.co.uk*. Since the installation of the new play equipment on the green, space has been reduced, so there will be a limit on the number of pitches, these will be allocated on a first come first served basis.

There will be entertainment throughout the afternoon including arena events, ladies' and men's Tug of War competitions between the bonfire societies for the bonfire cup, torch making competition and displays. Additionally, there will be the best of young local talent providing live music on the stage. This part of the extravaganza will be free entrance, although it is hoped all visitors will purchase a lucky programme to support the event.

Evening entertainment 6.00 pm to 10.00 pm

As in the past, the Society will have a stage for live music from several musicians, a headline band; there will be refreshments and a bar. At the end of the evening it is hoped to conclude the event with a small firework display to celebrate the Queen's birthday and another Olympic year. Report from Residents Association Meeting: 21 March 2016

Good Neighbours Scheme

It has been suggested that there may be a need for a Good Neighbour Scheme to be set up on Nevill to help vulnerable residents with day to day support. Gill Blackwell from the charity Action in Rural Sussex came to the meeting to explain how this works. She said that the scheme is formed by local volunteers to help people on an occasional or regular basis. They can do practical tasks, such as driving someone to hospital, helping with shopping, walking the dog, or befriending. Volunteers do not offer specialised care or play any role that should be left to professionals, or qualified services. Nor do they provide skilled tasks that would need a qualified tradesperson. The scheme mostly works through telephone contact. Coordinators receive calls for help and allocate tasks to appropriate volunteers. All the schemes' services are free, unless expenses such as petrol or parking have been incurred. Donations for running costs are usually welcome.

The aim is to help neighbours maintain a good quality of life, remain independent in their own homes, and reduce their reliance on statuary health and care support systems.

To set up a Good Neighbour scheme there needs to be group of like minded people to form a committee that can manage the formal procedures needed, such as preparing a constitution, choosing a coordinator, arranging a bank account, insurance, and Disclosure and Barring Service (DBS) checks etc.

Report from the Trustees of St Mary's Social Centre

Yes, it is good news for St Mary's that the Lewes District Council's New Homes project to build 415 homes across the district has been scrapped. It was a disgrace that St Mary's and other sites were included in a list of probable development areas, and since 2012 the Trustees have been fighting hard to overturn this decision. We were always prepared to consider the LDC / developer Karis offer of a new community centre built alongside some new housing on the site, but were also concerned about the disruption this would have caused to existing use of the centre.

So what happens now? We understand that LDC are still looking to build new affordable housing in the district as required by the government, but we hope the selection of sites will be better surveyed than the fiasco that happened under the previous administration. We believe, because of the outcry and 4000 signature petition obtained by St Mary's, LDC will not be considering us as a potential housing development at the moment. However, in March 2022 when the lease expires, will LDC consider renewing it or will they have other plans? We

We can see that there are three options.

- 1. Persuade LDC to sell the site to the Trustees. Preliminary enquiries have been made regarding a loan, but we need the District Council to come up with a valuation figure based on its current use.
- 2. Persuade LDC to devolve (transfer) the community centre to Lewes Town Council. We understand both councils are dragging their feet on other devolution sites which do not include St Mary's, so this option is not within the foreseeable future.
- 3. To continue to pressurise LDC to renew the lease in 2022. This is what we need to do if the other options are not forthcoming.

The option of doing nothing is not an option.

The Trustees are in discussion with the Supporters Club on refurbishing both the hall and club which has been delayed for over three years due to the uncertainty of proceedings. We aim to make St Mary's an attractive venue for Club members and Hall users alike and when we have a fair decision on the future, our aim is to keep the community centre alive for generations to come.

Possible Pedestrian Crossing on Nevill Road

Councillor Ruth O' Keeffe, Alan Chapman, NRA chairman, Ben Overton, a Nevill resident, met the ESCC Highways Safety Officer to discuss the possibility of a pedestrian crossing on Nevill Road, because poor visibility and traffic speed made it hazardous for pedestrians to cross the road. The conclusion was that a traffic island may help, but it would cost £15,000 -£20,000, and have to be paid for by the residents association, although match funding may be available.

Crime

PCSO Julie McNirlan would like to hear from anyone who has information about past arson attacks in Highdown Road, as she cannot find anything on record. Also, if you know anything about an attempted arson of a motorhome in Highdown Road in the early hours of 30 December 2015 contact the police quoting crime number CAD 1473 112016. On 11 November 2015 there was a break in South Way. The owners of the property were not in at the time and antiques and jewellery were stolen. On the same day a shed in South Way was broken into but nothing was taken. There was also a spate of similar break-ins in Houndean Rise. Environmental Budget

Following concern by residents over the lack of shade on Nevill Green, an application was made by the Tenants' Representative to the environmental budget for 5 trees and 2 benches, to create patches of shade and accessible seating. Tesco award for play and exercise equipment

Nevill Residents Association has been awarded £8,000 from Tesco's Bags of Help scheme – funded by the 5p carrier bag charge. The funds will pay for improvements to Nevill Green, including 'trim trail' equipment such as monkey bars and balance beams designed to appeal to all ages. The trail will complement the newly refurbished playground equipment and will be installed around the southern edge of the Green, leaving space for the annual sports day and other events on the green. Collection of Food Waste.

Concern had been raised at the January NRA meeting that food waste was being mixed with the general rubbish. This seemed to be still happening in certain areas. If residents spot a failure to recycle food waste properly they should contact District Councillor Tony Rowell - tony.rowell@greenparty.org.uk, who said he would look into the problem. To encourage more recycling the collection may be increased to once a week and household and food waste reduced to fortnightly.

Race Horses

Residents should be aware that race horses are using the twitten linking the Motor Road with Highdown Road. There have been confrontations between pedestrians and riders, with verbal abuse from the latter. The senior traffic officer said there was no suitable location for a barrier, but signage clarifying that the footpath was not for horses may help.
